The Articles of Association set out how the Trust is governed.

- Article 101 gives the trustees power to determine the constitution, membership and proceedings of any committee, and to review these at least every twelve months.
- Article 101 states that the membership of any committee may include persons who are not trustees, provided that (with the exception of the LGBs) a majority of members of any committee are trustees.
- Article 53 requires there to be a minimum of two parent governors on each LGB, unless there are a minimum of two parent trustees on the Trust Board.
